In Memoriam

Dr. Kelly A. Cheeseman, Chair of the Department of Sociology, Anthropology, and Criminal Justice at Messiah College, passed away unexpectedly on December 9 at the age of 38. She served as Chair of the Corrections Section of the Academy of Criminal Justice Sciences.

Dr. Cheeseman, who specialized in correctional issues, is remembered for her profound passion for her profession and for teaching and interacting with her students and fellow colleagues. She had an infectious sense of humor and a contagious smile. She was loved and will be missed by many.

Dr. Cheeseman attended the State of New York, Oswego and Youngstown State University, where she received her Bachelor's in Criminal Justice and Psychology in 1997. She received a Master's and a Ph.D. in Criminal Justice from Sam Houston State University, College of Criminal Justice in 1999 and 2006, respectively.

Dr. Cheeseman was a professor at several universities, including Old Dominion University, University of Southern Mississippi, and Messiah College. During her career, she also was a correctional officer at the Federal Bureau of Prisons at Allenwood in White Deer, PA and with the Texas Department of Criminal Justice at the Huntsville Unit.

Her areas of research included female sex offenders, prison deviance, correctional officer stress and job satisfaction, institutional corrections, the death penalty, ethics, and sexually deviant behavior.



Dr. Cheeseman was the co-author of Every Day Ethics for the Criminal Justice Professional and The Death Penalty: Constitutional Issues, Commentaries, and Case Briefs (2nd ed.). She published articles in such academic journals as Deviant Behavior, Criminal Justice Review, The Prison Journal, American Journal of Criminal Justice, Journal of Criminal Justice, Journal of Crime and Justice, Corrections Compendium, Criminal Law Bulletin, and Professional Issues in Criminal Justice.

Dr. Cheeseman also served as secretary of the Pennsylvania Association of Criminal Justice Educators. She was awarded the ACJS SAGE Junior Faculty Professional Development Teaching Award in 2009.

Dr Cheeseman, who lived in Enola, PA, is survived by her parents Charles and Marcia Cheeseman, sister Amy and husband Eric Powers, sister Debra Sickler, brother Charles Cheeseman Jr. and wife Wendy, five nephews and four nieces, as well as many other family and friends. SECTION AWARDS

Outstanding Student Travel Award

In 2011, the section began awarding the Outstanding Student Travel Award. Students presenting papers at the ACJS annual conference are encouraged to submit their papers to the Awards committee for consideration for receipt of the travel scholarship.

Outstanding Member Award

Criteria for nomination for the Outstanding Member award are: 1) membership in and preferably contribution to the ACJS Corrections Section and 2) significant research and/or scholarship in the field of corrections. Winners will receive a \$100 cash award and a plaque of recognition. They will also be honored at the annual Corrections Section Award meeting. Self-nominations are allowed and encouraged.

John Howard Award

The John Howard Award is given intermittently, upon significant demand, to recognize an individual who has made significant and sustained contributions to the practice of corrections. The nominee MUST have made significant contributions to practice, but also can have made significant contributions in scholarship, teaching, policy, or service. Nominators can make the argument that a nominee's scholarship or work in teaching, policy, or service DID make a significant contribution to practice. This is encouraged. Nominations are accepted every year and the committee will seriously consider all nominees. However, the awarding of this honor is solely at the Committee's discretion and may not be awarded each year. Nominees should send a description of the nominee's contributions, explaining how the nominee meets or exceeds the criteria, along with a copy of the nominee's CV to the Chair of the Awards Committee.
