



Reciprocal Agreement between Criminological Society of Africa (CRIMSA) and the Academy of Criminal Justice Sciences (ACJS)

Reciprocal Agreement to Affiliate: 2 March 2018

This document, which has been agreed to by the Criminological Society of Africa (CRIMSA) and Academy of Criminal Justice Sciences (ACJS), sets out parameters of an agreement to affiliate.

Terms of the affiliation include the following:

- I. Information will be exchanged on an informal basis, including within the newsletters of the respective societies and via websites and social media as appropriate.
- II. Upon request, a one-page advertisement will be made available by each party in relevant newsletters to advertise respective annual conferences.
- III. Members of each association will be permitted to attend the other association's annual conference at the member rate.

The following controls will apply to this reciprocal agreement:

- I. This reciprocal agreement does not constitute a legal transaction. It is undertaken informally and in good faith between each association.
- II. This agreement will be terminated whenever a breach of good faith occurs, or under any other circumstance in which either the CRIMSA council or the ACJS board and/or authorised representative decides that the agreement negatively affects existing membership (e.g. a significant "migration" of members from one organisation to another). The agreement will be terminated whenever such a breach is declared by the CRIMSA council or the ACJS board and/or authorised representatives which reflects negatively upon the CRIMSA or ACJS mission or general image.
- III. This agreement does not involve any direct or indirect exchanges of monies between CRIMSA and the ACJS, though each association may choose to sponsor events or activities at the other organisation's conference as appropriate.



IV. This reciprocal agreement will not involve any other mutual agreement between the CRIMSA and the ACJS except where it is agreed to by the associations' respective boards and executive councils.

This agreement is ratified by CRIMSA members, council and executive committee and the ACJS members, board and executive committee and signed by the presidents and executive directors or a member of the executive council (if applicable) of each organisation. The executive director (or president if there is no executive director) of each organisation will be involved as the facilitator, ensuring the long-term maintenance of the agreement and will coordinate practical aspects of the agreement. In the case where the term of a president and executive directors or members of the executive council (if applicable) of each organisation ends, the affiliation and responsibilities will automatically be carried over to the incoming management structures (i.e. president and executive director, members of the executive council or board and the relevant secretaries).
